Simply present your pass at any attraction you visit – the staff will log your Lake District pass and admit you. Just remember the following points:

The Lake District Pass is not a fast-track pass.

You can only use your pass once at any given attraction.

Lake District Passes purchased online are non-transferable and non-refundable – it's important to consider purchasing cancellation cover if your travel plans may change.

The 48-Hour Lake District Pass operate by calendar day. The 48-hour Lake District Pass offers two consecutive calendar days.

Opening times will fluctuate from time to time and users of information on this web site are recommended to check with the Attraction concerned prior to visiting it to ascertain the current position.
